**Terms and Conditions**

By borrowing a Chromebook from this library, the patron acknowledges that the use of this equipment is contingent upon the terms and conditions listed below.

Please initial next to each item to indicate understanding and acceptance of these terms and conditions:

- \_\_\_ In order to borrow a **Take Home Chromebook**, a library patron must be 18 years of age or older and be a Silver Falls Library patron with a CCRLS (Chemeketa Cooperative Regional Library Service) library card in good standing. Parents/guardians are responsible for the use of the Chromebook by minors.
- \_\_\_ In order to borrow a **Library Use Only Chromebook**, a library patron must be 18 years of age or older with a CCRLS (Chemeketa Cooperative Regional Library Service) library card in good standing. Parents/guardians are responsible for the use of the Chromebook by minors.
- \_\_\_ Only one Chromebook may be borrowed on a patron's account at any one time.
- \_\_\_ Overdue Chromebooks will be deactivated if in an overdue status.
- \_\_\_ Overdue fines will accrue at \$5.00 per day up to \$50.00. When the Chromebook is considered lost, you will be billed the following charges:
  - Chromebook                      \$300.00
  - Case                                 \$16.00
  - Adapter and/or cable         \$15.00
  - Processing fee                   \$5.00
  - Overdue fees                     see above
- \_\_\_ Chromebooks must be returned inside during open hours to the Reference Desk. A \$25.00 fee will be charged if the Chromebook is returned in the book drop, or \$300.00 if the Chromebook is damaged.
- \_\_\_ By borrowing and using the Chromebook, the user agrees to abide by terms of use in this agreement, and to hold the Silver Falls Library harmless from any and all claims, losses, damages, obligations, or liabilities, directly or indirectly, relating to the use of the Chromebook and internet access provided.
- \_\_\_ Deliberate altering of any files or modifying the configuration of the equipment is strictly prohibited and may jeopardize the individual's eligibility for borrowing a Chromebook in the future. Internet service relies on cell tower technology and coverage. Service outside the continental United States is prohibited. User experience can vary based on location.

- \_\_\_ Silver Falls Library is not responsible for personal information shared over the internet or for information or websites accessed, or for any liability, damages, or expense resulting from the use of the Chromebook.
- \_\_\_ Chromebooks must be kept in a dry, temperature-controlled environment, or it will damage the device. Do not leave the Chromebook in vehicles or in extreme temperatures.
- \_\_\_ Unlawful use of the internet is prohibited and may result in the loss of Chromebook privileges.
