Terms and Conditions

By borrowing a T-Mobile hotspot from this library, the patron acknowledges that the use of this equipment is contingent upon the terms and conditions listed below.

Please initial next to each item to indicate understanding and acceptance of these terms and conditions:

- ___ In order to borrow a **T-Mobile hotspot**, a library patron must be 18 years of age or older and be a Silver Falls Library patron with a CCRLS (Chemeketa Cooperative Regional Library Service) library card in good standing. Parents/guardians are responsible for the use of the hotspot by minors.
- ___ Only one hotspot may be borrowed on a patron's account at any one time.
- ___ Overdue hotspots will be deactivated if in an overdue status.
- ___ Overdue fines will accrue at \$5.00 per day up to \$50.00. When the hotspot is considered lost, you will be billed for a replacement charge.
- ___ Hotspots must be returned inside during open hours to the Reference Desk.
- ___ By borrowing and using the hotspot, the user agrees to abide by terms of use in this agreement, and to hold the Silver Falls Library harmless from any and all claims, losses, damages, obligations, or liabilities, directly or indirectly, relating to the use of the hotspot and internet access provided.
- ___ Deliberate altering of any files or modifying the configuration of the equipment is strictly prohibited and may jeopardize the individual's eligibility for borrowing a hotspot in the future. Internet service relies on cell tower technology and coverage. Service outside the continental United States is prohibited. User experience can vary based on location.
- ___ A hotspot can usually provide Internet access for multiple devices. Individuals who check out the hotspot are responsible for any hotspot use extended to others.
- ___ Silver Falls Library is not responsible for personal information shared over the internet or for information or websites accessed, or for any liability, damages, or expense resulting from the use of the hotspot.
- ___ The borrowing patron will be responsible for lost or damaged hotspots and any accompanying accessories (includes theft thereof). Patrons must be mindful of current replacement costs of mobile hotspots and accessories before borrowing.
- ___ The borrowing patron understands that hotspots must be kept in a dry, temperature-controlled environment, or the device can be damaged. Do not leave the hotspot in vehicles or in extreme hot or cold temperatures.

- ___ Unlawful use of the internet is prohibited and may result in the loss of hotspot privileges.
- ___ For assistance in the operation of the Silver Falls Library hotspot, contact the Silver Falls Library Reference Desk at 503-873-8796.
